### Overview

Ben also appears regularly at appellate level. He has successfully brought and resisted various appeals in the EAT and has been led in high profile and widely reported decisions of the Court of Appeal (including *Burn v Alder Hey Children's NHS Foundation Trust* [2021] EWCA Civ 1791, [2022] ICR 492, [2022] I.R.L.R. 306, (2022) 184 B.M.L.R. 108 and *Coletta v Bath Hill Court* [2019] EWCA Civ 1707, [2020] 3 All E.R. 59, [2020] I.C.R. 703, [2020] I.R.L.R. 124).

Before coming to the Bar, Ben also worked on labour law as an academic lawyer. In this mode, he attended various international conferences to present papers on UK employment law and he continues to contribute to publications in the field.

## Investigations and Internal Processes

---

Ben regularly accepts instructions to conduct all forms of internal processes in the workplace.

His recent experience includes:

- Investigating various grievances brought by senior/director level employees (both as sole/lead investigator and as a member of a multi-investigator team);
- Investigating allegations of misconduct (including various forms of alleged discrimination/harassment) by staff in public, private and third sector organisations;
- Investigating allegations by members of the public in respect of the provision of goods and services (including making recommendations for further action in respect of involved staff and also identifying institutional issues);
- Conducting appeal processes in respect of decisions made by internal decision makers;
- Investigating union rule book complaints; and
- Acting in MHPS proceedings (at consultant level) on both sides (as well as acting, led, in MHPS-related High Court proceedings).

Ben has conducted such processes for publicly listed firms, SMEs, charities, a regulator, universities, private schools, and unions.

## Professional Regulatory & Discipline

---

Ben has experience of matters progressing before various regulators (from initial investigations, through interim-orders hearings, to final disposal).

He appeared in the leading case on the scope of the right of appeal to the High Court against the sanction of erasure (*Sastry and Okpara v GMC* [2021] EWCA Civ 623, Times Law Reports 21 May 2021, led by [Nicola Newbegin](#)).

As noted under 'internal processes', above, as well as having acted on behalf of senior medical practitioners and NHS Trusts in employment proceedings, Ben has also been instructed in internal disciplinary proceedings by Trust management. Ben has hands-on experience of cases involving overlapping processes (including counter-fraud and criminal investigations alongside internal disciplinary and other employment disputes).

Ben also has a history of engagement with medical practitioners stretching long before his call to the bar (through his academic research on, and volunteering work in relation to, the regulation of stem-cell research).

## DBS Appeals

---

He appeared (led by [Betsan Criddle KC](#)) in the then leading decision on the nature and extent of the Upper Tribunal's jurisdiction to correct errors of fact (*PF v DBS* [2020] UKUT 256 (AAC)).
