# **Professional Regulatory and Discipline**

Daniel has considerable experience of acting on both sides of the regulatory fence. He has defended nurses at the Nursing and Midwifery Council and prosecuted dentists at the General Dental Council. His cases have covered a panoply of performance, conduct, competence and health issues (including interim orders), and he has the unusual distinction of never having had a nurse struck off the register.

#### **Notable Cases**

#### **Personal Injury**

- Fatal accident case. Million-pound claim by several dependants involving capacity issues. Settled at JSM. Claimant instruction.
- Employers' liability case. Claim against the MoD for career-ending injuries leading to chronic pain condition. Substantial loss of earnings and pension claims. Settled at JSM. Claimant instruction.
- Public liability case. Claim following alleged slipping accident; finding of fundamental dishonesty made at trial. Defendant instruction.
- Employers' liability case. Claim for more than £300,000 for permanent back injury, reduced to less than £20,000 at trial on basis of short-term acceleration. Defendant instruction.
- Road traffic accident. Half-a-million-pound claim by young gamekeeper with career-ending injuries. Settled at JSM. Claimant instruction.

### **Clinical Negligence**

- Shoulder surgery case. Claim arising from delayed diagnosis of tumour, leading to complex shoulder surgery and permanent functional limitations. Settled at JSM. Claimant instruction.
- Double-amputation case. Claim arising from negligent nursing care, leading to sepsis and amputation. Ongoing. Claimant instruction.
- Dental case. Claim arising from delayed diagnosis of multiple meningiomas, with complex causation issues. Ongoing. Defendant instruction
- Obstetrics case. Claim for death of baby following negligent management of childbirth. Settled. Claimant instruction.
- Ophthalmology case. Claim arising from delayed diagnosis of glaucoma leading to deteriorated vision and risk of blindness. Settled. Claimant instruction.
