Overview

Laura Gould's practice encompasses employment, sports and commercial law.

Laura has been recognised as a leading individual in both employment and sports law by both Chambers & Partners and Legal 500. Laura's expertise was recognised by her nomination for Employment Law Junior of the Year at The Legal 500 Bar Awards 2023. She is one of only four juniors ranked for Sports Law outside of London in Chambers & Partners (2024) and one of only five in Legal 500 (2024). She will continue to pursue her practice throughout the UK.

Laura appears in employment tribunals throughout the UK for both Claimants and Respondents including British Airways, John Lewis PLC, Rolls Royce, Unite the Union and the National Education Union. Laura also acts in employment-related High Court actions, as well as discrimination claims pursued in the civil courts, and civil claims brought against unions by their members.

Laura's work has a particular focus on health sector employment, acting for various NHS Trusts and GP practices as well as private medical and care providers. She also acts for medical professionals, being instructed both on a private basis and through the BMA.

Laura's commercial employment work has involved issues of breach of confidentiality, restrictive covenants, inducement, conspiracy and conversion. She also deals with overlapping TUPE and insolvency matters.

Laura has experience in a wide range of other commercial work including insolvency proceedings, partnership disputes, contractual disputes and consequent enforcement proceedings.

Laura's growing sports law practice has included advising and representing parties on matters such as allegations of racism, club to club bonus contractual disputes, anti-doping breaches in both people and horses, contested boxing promotional rights and FA Agents Regulations. Laura sits on appeal panels for British Cycling.

Laura provides regular CPD training and has had articles published in the Financial Times, Personnel Today, People Management Magazine and the Manchester Evening News. She has recorded a podcast for CPDCast entitled 'A Practical Introduction to Employment Law'.

Employment & Discrimination Law

Laura appears in employment tribunals throughout England and Wales, and Scotland.

Her work often involves allegations of mental health disability discrimination, particularly neurodiversity-related claims, and detrimental treatment/dismissal for having made public interest disclosures.

Laura's work has a particular focus on health sector employment, acting for various NHS Trusts and GP practices as well as private medical and care providers. She also acts for medical professionals, being instructed both on a private basis and through the BMA.

In her non-medical work, Laura regularly acts for large employers, particularly in the retail sector; this includes regularly representing John Lewis plc, a loyal client for many years. Recent instructions have also included acting for companies such as Rolls Royce and Babcock International (a large multi-national defence contractor), as well as public sector employers, such as local authorities.

Additionally, Laura acts in employment-related High Court actions, as well as discrimination claims pursued in the civil courts, and civil claims brought against unions by their members.

Recent examples of Laura's work include:

- In early 2023, acting for s suspended Chief Executive of a high profile NHS Trust in seeking an injunction to restrain her continued suspension.
- Acting for a defendant NHS Trust in a High Court claim brought by a consultant arising from his suspension by the Trust.
- Acting for a claimant former teacher in a remedy hearing involving issues of substantial pension loss in which the award exceeded (and was therefore limited) to the statutory cap.
- Representing a claimant in a 10-day liability hearing involving allegations of detrimental treatment due to making protected disclosures and disability discrimination. Claims of disability discrimination succeeded and an expert has been instructed to report on the claimant's neurological disorder.
- Representing a respondent NHS Trust in a 15-day liability hearing involving allegations of trade union detriment, direct sex discrimination (brought by a man in a predominantly female workplace), direct disability discrimination, discrimination arising from a disability as well as harassment on the grounds of sex and disability.
- Acting for a respondent NHS Trust in a claim of unfair dismissal and disability discrimination, including an appeal against the finding of disability status at a preliminary hearing, where Laura obtained a strike out of the unfair dismissal claim. The claimant withdrew her remaining claims during the final hearing, following Laura's cross-examination of her.
- Acting for an international economic forecasting company at first instance and appeal in successfully resisting a claim of automatically unfair dismissal, and the subsequent appeal, contended to arise from the claimant's membership of the reserve armed forces.
- Acting for a Welsh local authority in a hybrid hearing with elements of simultaneous translation. Claims were brought alleging unfair dismissal and disability discrimination. The Tribunal decided to hear the respondent's evidence and that of various witnesses in support of the claimant first. The claimant withdrew her claim on the morning of day 7 of the hearing, whilst part-heard in her evidence, after Laura had crossexamined her for one day.

Sport

Laura's practice spans a wide range of sports, including football, rugby union, rugby league, cycling, squash, boxing, wrestling, harness racing, basketball, sailing and golf. She has dealt with a wide range of contractual, disciplinary, safe-

guarding and regulatory issues, including anti-doping violations, Rule K and Sports Resolutions-administered arbitrations. Examples include:

- Rugby Union: Laura regularly presents/prosecutes cases on behalf the Rugby Football Union. Such cases have involved race discrimination at local clubs up to very senior participants. Cases have included issues of jurisdiction in relation to social media posts and interpretation of sanctions since the wider recognition and awareness of structural racism. Cases have also involved anti-doping, safeguarding, and breaches of Covid regulations involving players up to international level.
- <u>Cycling:</u> Laura sits on disciplinary and appeal panels for British Cycling.
 This involves sitting as a wing member of a 3-person panel, and determining appeal procedure compliance on the papers.
- Football: Advising and acting on football matters including:
 - Breaches of contract in relation to payments to members of a management team following relegation from the Premiership;
 - Club to club bonus contractual disputes at EFL Championship level:
 - o Breach of contract by a player undertaking international duties;
 - Disputes about the application of FA Rule K arbitration requirements; and
 - o FA Agents' Regulations.
- **Squash:** Acting for the squash world champion in an appeal against disciplinary conduct findings and sanction.
- **Wrestling:** Sitting as an independent observer on the Commonwealth Games selection panel of a national governing body.
- <u>Boxing:</u> Successfully representing a promoter in the Mercantile Court, in obtaining a world-wide injunction and damages arising from a dispute with a boxer's former agent.
- Horse-racing Acting in a case seeking to invoke the High Court's jurisdiction to review disciplinary sanctions in a harness racing case.

Laura recently wrote and delivered a seminar on dealing with race discrimination complaints in a sporting context, following her instruction in a number of race discrimination cases acting both for governing bodies and separately for sports participants, including a professional referee. She has also provided training to sports organisations on neurodiversity and whistleblowing complaints.

Commercial Litigation

Laura has experience in a wide range of other commercial work including insolvency proceedings, partnership disputes, challenges to business rates, contractual disputes and consequent enforcement proceedings including charging orders and orders for sale.

Laura has a particular interest and experience in the overlapping areas of TUPE and insolvency proceedings.

Laura has been instructed in commercial employment work including applications for urgent injunctive relief, issues of breach of confidentiality, restrictive covenants, inducement, conspiracy and conversion, breaches of directors' duties and breaches of employment contracts.

In addition, Laura undertakes work involving breaches of non-employment contracts, non-employment related injunctions, professional negligence, insolvency and enforcement proceedings.

She is experienced in civil court litigation and is able to deal with applications and other instructions on an urgent basis. Laura provides a pragmatic and commercial approach to proceedings. Her employment law practice has allowed her to gain significant experience in trial advocacy.
