### Overview

## Professional discipline & regulatory

---

Tara acts for professionals at all stages of fitness to practise proceedings including interim order and substantive hearings. ## Personal Injury & Inquests

---

She also has a busy inquest practice.

- Advising a nurse attacked by a psychotic patient in a large London hospital;
- Advising a police officer bullied at work by senior members of staff;
- Advising a claimant injured in the Shoreham Airshow crash;

## Clinical Negligence

---

Tara acts for both claimants and defendants across a wide range of clinical negligence claims. She has been seconded to a defendant clinical law team and is well-versed in NHS protocols and approaches to clinical negligence claims.

Tara has extensive evidence of working with medical experts, adopts a collaborative approach with experts and solicitors to obtain the best outcome for the client.
