## Foreword

Old Square Chambers are committed to the principles of Equality and Diversity in all areas of our operations, from our membership and access to the Bar as a profession, to our service provision to our clients, professional and lay.

In accordance with Rule rC110 of the Equality Rules of the Bar Standards Board, the following report outlines an overview of the demographic of Chambers, by protected characteristic.

It is important to note that the provision of diversity data was voluntary. As such, a small number of barristers and staff declined to provide diversity data. A proportion of members and staff did not consent to the publication of data if there were fewer than 10 individuals with the same protected characteristic.

Data was provided by 61 barristers and 9 staff. We are therefore publishing the following summary of the responses to the diversity collection questionnaires provided by 72% of those invited to participate.

The data has been analysed by Chambers' Diversity Data Officer as required by the BSB Handbook and Equality Rules Handbook, including by reference to bands of seniority of barristers within Chambers and the responsibilities of staff.




Q2. Do you have responsibility for supervising or managing the work of lawyers or other employees?


Q3. From the list of age bands below, please indicate the category that includes your current age in years:


Q4. What is your sex?


Q5. Is the gender you identify with the same as your sex registered at birth? If no please enter gender identity.


Q6. Do you consider yourself to have a disability according to the definition in the Equality Act?


Q7. Are your day-to-day activities limited because of a health problem or disability which has lasted, or is expected to last, at least 12 months?

Q8. What is your ethnicity?




## Q9. What is your religion or belief?


Q10. What is your sexual orientation?


Q11. If you went to University (to study a BA, BSc course or higher), were you part of the first generation of your family to do so?


Q12. Did you mainly attend a state or fee paying school between the ages of 11-18?
